



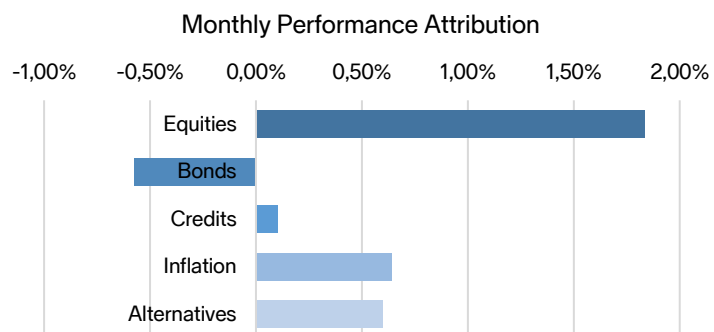
Monthly Comment

The global economy shows continued growth so far in the third quarter and investors remained positive in August. A better-than-expected reporting season and hopes for a vaccine seem to have raised the economic expectations. Although earnings per share decreased by 33% compared to the previous year in the US, 84% of companies beat the expectations and a large number raised their forecasts for the upcoming quarters. Not surprisingly, the health care and information technology sectors were strong, while revenues from the energy sector were more affected by the pandemic. Many believed that the spread of Covid-19 would slow down sharply during the summer but the virus has unfortunately continued to spread. We now have over 25 million cases globally, compared to 10 million in the beginning of July. Some regions in Europe and the US are facing a second wave, but better testing and tracking capabilities have enabled European decision-makers to treat the second wave differently with targeted actions such as travel restrictions or requirement to wear a face mask, instead of shutting down entire regions or countries.

Risky assets and equities continued to climb in August. Emerging markets rose by 2.2% and developed markets by 6.7%, with US and European equity as key drivers. Interest rates rose particularly for longer maturities. Global government bonds fell by 0.2%. Credits, inflation and Alternatives also contributed with positive return. Nordnet Smart Portfolios had their best month in 2020 and the third best month since they were launched. Exposure to risky assets, particularly equity, has increased because of the decline in volatility and sustained trends.

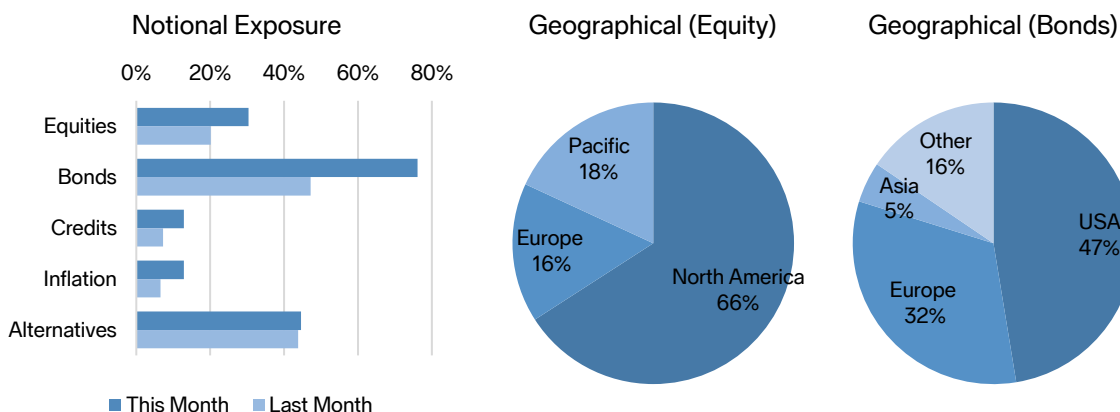
